New Regulation: SACHDNC Recommendations

- Recommendations from the Department of Health and Human Services' (DHHS) Secretary's Advisory Committee on Heritable Disorders in Newborns and Children (SACHDNC)
 - "Initial NBS specimens should be collected in the appropriate time frame for the newborn's condition but no later than 48 hours after birth, and
 - NBS specimens should be received at the laboratory as soon as possible; ideally within 24 hours of collection."

New York State Department of Health (NYSDOH) endorses these recommendations, although the new regulation is actually more stringent (collection at < 36 hours).

New Regulation: It's Here!

 "Newborn Screening for Phenylketonuria and Other Diseases," Subpart 69-1 of Title 10 (Health) of the Official Compilation of Codes, Rules and Regulations went into effect on February 13, 2019
















Specialty Care Centers (SCC)



Health care facility established under Article 28 of New York State Public Health Law which is approved by the Department of Health and certified by the Wadsworth Center for Laboratories and Research to provide evaluation, treatment and/or services to children identified by the NBS Program.



Specialty Care Center Certification Process

- Review criteria for approval as a SCC
- Application
- Application review and interim approval
- Site visit
- Approval





Responsibilities of the SCC Director



 Submitting to the NBS Program, within the time frame for each condition as directed by NBS Program, the diagnostic evaluation, test results and treatment plan for each newborn referred to the SCC.



SCC Responsibilities: Family Education

 The SCC shall provide education, identify resources and any additional assistance to the newborn's parent(s).





SCC Responsibilities: Medical Consultation




 The SCC shall provide consultation and assistance to hospitals, responsible providers, the testing laboratory and other health providers upon request.



SCC Responsibilities: Case Information

 The SCC shall provide initial and subsequent case information, case management, treatment plan, specimens and other information for tracking and follow-up reviews to the testing laboratory, when requested.

SCC Responsibilities: SCC Changes



 The SCC shall submit written and/or electronic notification to the testing laboratory within thirty (30) days prior to the effective date of appointment of a new Director or change in the location of the SCC.



SCC Responsibilities: Contact Information

The SCC shall provide the NBS
 Program with the names and contact information for all personnel, annually, and within ninety (90) days of any request from the NBS Program for such information.





Coming Soon: Certification Maintenance

- The NYS NBS Program is implementing an assessment and follow-up process for maintenance of SCC certification
- Goals of this initiative:
 - Improve time from referral to diagnosis
 - Reduce number of cases lost to follow-up
- Benchmarks are being established and reports will be issued for each
 SCC to see how they are performing
- Each SCC will be asked to:
 - Submit their protocol for handling NBS referrals
 - Submit an updated contact list
